The annual LAO report gives us a detailed look at the fiscal health of the state budget in comparison to the State of California Adopted Budget and is used as a guide for what fiscal shortfall or surplus needs to be addressed by the governor and legislature in the coming fiscal year. Following the release of the LAO report we will receive the Governor's State Budget on or before January 10, 2024. Information regarding the 2023-2024 and 2024-205 budget will be shared with the Board as it becomes available.
